ASSUMPTION OF RISK, RELEASE OF LIABILITY, AND INDEMNITY

By signing this document, I agree to the following:

1. **Risk of Travel Abroad:** I understand that international travel as part of my participation in the Global Outreach Alliance team expedition program and/or volunteer experience ("Program") specified above involves risks, dangers, and hazards that may not be found in the United States or other developed countries. These includes, but are not limited to, risks involved in traveling to and within, and returning from, one or more foreign countries; foreign political, legal, tribal, social, seasonal, geographic, weather and economic conditions; different standards of design, safety, and maintenance of buildings, public places, and conveyances; the possibility of unclean or contaminated food and water; numerous diseases, substandard local medical treatments, facilities and expertise; unstable governments; lack of police protection; substandard or dangerous modes of transportation (e.g. motorcycles, taxis and buses with possible irresponsible, inadequately-trained drivers); and poor living conditions, and that such participation could result in severe injury and even death. I also know and understand that traveling to and living in developing countries involves inherently dangerous activities that no level of training, instruction, preparation, supervision, facilitation, or enforcement of rules by Global Outreach Alliance, its personnel, trustees, partners, local affiliates, officers, employees, volunteers, team leaders, team members, or representatives can guarantee to prevent or eliminate. With full knowledge and understanding of these risks, I freely and voluntarily accept and fully assume the risk that I may suffer temporary, permanent, or even fatal injuries while participating in a Global Outreach Alliance Program.

Also, in consideration of Global Outreach Alliance permitting me to participate in this program, I agree to comply with and be bound by the terms of this Assumption of Risk, Release of Liability, and Indemnity. I specifically and unconditionally agree (or, if I am a minor, my parent or legal guardian specifically and unconditionally agrees):

- a. To not sue Global Outreach Alliance for, to waive and release Global Outreach Alliance of, and to hold harmless, defend, and indemnify Global Outreach Alliance against all present and future liability, claims, demands, injuries (including death), causes of action, charges, and damages sustained by or incurred by me, my property, or any third party arising from or

related to my participation in the program, regardless of the cause, including, without limitation, the negligence of Global Outreach Alliance.

- b. To hereby assume the risk of and relieve Global Outreach Alliance from any duty to protect me from harm in connection with the Program.
 - c. That this Agreement shall be construed in accordance with and governed by the substantive and procedural laws of the State of Utah, without reference to principles governing conflicts of laws; that this Agreement shall be construed as broadly and as conclusively as permitted by Utah law; that all lawsuits and legal proceedings arising from or related to my participation in the Program shall be maintained in state or federal courts sitting in Salt Lake County, Utah; that jurisdiction and venue for such lawsuits and legal proceedings shall lie exclusively with such courts; and that the terms of this Agreement are severable, and if any such term is found to be unenforceable, then the remaining terms shall be fully enforceable.
2. **U.S. State Department & Health Travel Advisory Status:** I understand that it is required that I will familiarize myself with information about the country and/or region I am going to, including the most current travel alerts and warnings and consular information sheets by the U.S. Department of State (<http://travel.state.gov>) and the most current health warnings issues by the U.S. Centers for Disease Control and Prevention (<http://www.cdc.gov/travel>), which may contain information about the inherent dangers and difficulties specific to the country or region of my destination. I understand that one or more of the countries that I plan to visit may have a travel alert or warning issued by the U.S. State Department that describes a heightened risk of travel in that area. I understand that travel alerts may change to more urgent status including “travel warning” with little or no notice. I understand and agree that a change in U.S. State Department travel advisory status or other safety concerns may result in Global Outreach Alliance suspending a Program and official travel in the affected countries (before departure or during a given Program), and that I may be directed to not travel or return to the U.S. or relocate to a safer location at my own expense. By signing this document, I certify that I have read and understand the U.S. Department Travel Alert and Center for Disease Control warnings/requirements (if pertinent) concerning my destination country as stated above in accordance with the Program.
 3. **Independent Activity:** I understand that, in addition to the other provisions of this agreement, Global Outreach Alliance is not responsible for any injury or loss I may suffer when I am traveling independently or am otherwise separated or absent from any organization-sponsored activities.
 4. **Health and Safety:** I acknowledge that Global Outreach Alliance expects all participants to purchase or upgrade to international health insurance coverage. I am aware that it is my sole responsibility to ensure that I am covered with all necessary medical, emergency evacuation, and travel insurance for my Program, and Global Outreach Alliance is not responsible for my negligence if I forge or fail to obtain insurance. I am aware of all applicable personal medical needs. I have arranged, through insurance or otherwise, to meet any and all needs for payment of medical costs while I participate in this travel. I recognize that Global Outreach Alliance is not obligated to attend to any of my medical, emergency or medication needs, and I assume all risk and responsibility for those needs. If I require medical treatment or hospital care in a foreign country during my travel, Global Outreach Alliance is not responsible for any or all associated costs or quality of such treatment or care, or injuries arising

from or related to such care. In addition, if a natural disaster or social catastrophe (such as violent protests or political uprisings) were to occur anytime in route or in country throughout participating in a Global Outreach Alliance Program, I understand and assume all financial obligations that could transpire therein to relocate or return home. Moreover, in case of an emergency or if anything were to affect my overall health or safety, if the Program is interrupted or if the Program's participants are scattered due to any kind of unforeseen event and I were required or prompted to immediately relocate or return home, I understand that Global Outreach Alliance is not responsible, and therefore, I would assume all associated personal responsibility, including transportation costs and associated travel fees that could incur. I have also consulted or will consult a physician or reviewed material that lists suggested or required vaccinations for the given country or countries I will be traveling to. I assume all risk and responsibility for meeting in-country vaccination expectations, including that of carrying an inoculation certificate.

5. Observance of Law and Entrance/Exit Requirements:

- a. I understand that each country has its own laws and standards of acceptable conduct, including dress, manners, morals, politics, drug use, entrance and exit requirements, and behavior. I recognize that behavior which violates those laws or standards could harm Global Outreach Alliance's relations with those countries and institutions therein, as well as my own health and safety. I understand that Global Outreach Alliance is not responsible for providing any assistance, legal or otherwise, in dealing with the laws or standards of foreign countries. I will become informed of, and abide by, all such laws and standards for each country to or through which I will travel, and accept any consequences of violations thereof.
- b. I understand that each country has its own laws and standards for entrance and exit within its territories and borders. I recognize that behavior which violates those laws or standards for entry/exit could lead to immediate deportation or expulsion, which would be at my own expense. I understand that it is my responsibility to be aware of any and all entry and exit requirements to the country or countries I plan to travel to or through. I understand it is my responsibility, and not that of Global Outreach Alliance, to plan ahead and be prepared to meet and abide by all rules, regulations, policies and laws for my given nationality and/or citizenship status to enter and exit any country I plan to travel to or through as part of my participation in this Program. I understand it is my responsibility to understand and purchase the visa option (if necessary) that is most suitable for Program participation and country entrance. I understand it is my responsibility (as well as my personal expense) to ensure that my passport and visas are up-to-date and in accordance with local law and border customs, as well as to be prepared with any documentation, birth certificates, photos, inoculation certificates and or statements which may be required by local or consulate authorities.

6. Standards of Conduct:

- a. I agree to comply with Global Outreach Alliance's rules, standards, and instructions for volunteer participant behavior. I waive and release all claims against Global Outreach Alliance that arise at a time when I am not under the direct supervision of Global Outreach Alliance's supervisors or institutions, or that are caused by my failure to remain under such supervision or to comply with such rules, standards, and instructions.

b. I agree that Global Outreach Alliance has a right to enforce the standards of conduct described above, in its sole judgment, and that it will impose sanctions, up to and including expulsion from this Program, for violating these standards or for any behaviors detrimental to or incompatible with the interest, harmony, and welfare of Global Outreach Alliance and other participants or third parties. If I am expelled, I consent to being sent home at my own expense with no refund of fees.

7. **Assumption of Risk and Release of Claims:** Knowing the risks described above, and in consideration of being permitted to participate in this volunteer travel Program, I agree, on behalf of my family, heirs, and personal representative(s), to assume all risks and responsibilities surrounding my travel and stay as part of this Program or activity. To the maximum extent permitted by law, I release and indemnify Global Outreach Alliance, and the trustees, officers, employees, partners, volunteers, and agents, from and against any present or future claim, loss, or liability for injury to person or property which I may suffer, or for which I may be liable to another person, group or organization during my participation in this travel activity (including periods in transit to or from any country that is part of this program).
